Sub: - Debarring of defaulting artisans in Master Creations 1 organized by the Office of DC (HC) at Dilli Haat, INA, New Delhi w.e.f. 16.10.2025 to 31.10.2025 - regarding.

The inspection was undertaken by the officers of Northern Regional office in the Master Creations 1 (2025) event. The artisans whose detail are given below were found to defy the guidelines for participation in Dilli Haat. The craft displayed were other than those the craft mentioned in Pehchan Card and artisans were not available on stall. The stalls were closed immediately and as per the recommendations of Regional Director, Northern Regional Office and consequent approval of the competent authority, these artisans have been debarred with immediate effect for a period of two years i.e. upto 01.01.2028 from all the benefits under various scheme of Office of Development Commissioner (Handicrafts).


